Gift Aid

Did you know that the National Galleries of Scotland can increase the value of your donation or membership by claiming Gift Aid? There is no extra cost to you and the process is simple – all you have to do is make a Gift Aid declaration.

This declaration does not commit you to anything; it just ensures that we can reclaim the tax paid on your donation from HM Revenue & Customs. To confirm that you are happy for us to reclaim Gift Aid please check that the declaration below reflects your circumstances and please complete and return it to us at the Patrons Office.

You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the National Galleries of Scotland, the Foundation, and all other charities and CASCs reclaim on your donation in the tax year (currently 25p for each £1 you give). If you pay less tax than the amount of Gift Aid claimed on all your donations in a tax year it is your responsibility to pay any difference.

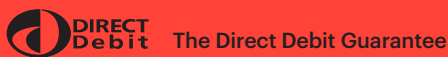

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit the National Galleries of Scotland will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request the National Galleries of Scotland to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by the National Galleries of Scotland or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- If you receive a refund you are not entitled to, you must pay it back when the National Galleries of Scotland asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
